

Owner Agreement

I, _____ hereby certify that my dog(s):

is/are in good health, have not been ill with any communicable diseases or parasites in the last 30 days, and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I also have read and understand and agree to the following:

- 1. Sandy Pawz Dog House provides a playground environment with interaction with other dogs, which could result in the following:
 - a. Transmission of an illness such as, but not limited to: the Bordatella virus (also known as "kennel cough"), the canine papilloma virus (also known as "puppy warts"), or parasites.
 - b. Accidental injuries such as broken nails, abrasions, cuts, muscle pulls, etc. especially in breeds with shorter coats, as well as in dogs more prone to injury
 - c. Behavioral problems

- If any health or behavioral problems develop with my dog(s), that these will be treated as deemed best by the staff of Sandy Pawz Dog House within their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
- 3. Sandy Pawz Dog House and their staff will not be liable if any health or behavioral problems arise following my dog(s) attendance and interactions at Sandy Pawz Dog House.
- 4. I am solely responsible for any harm caused by my dog(s) while attending Sandy Pawz Dog House to any other dog(s), to the employees or invitees of Sandy Pawz Dog House, or to the equipment or other property of Sandy Pawz Dog House.
- 5. Photographs or other graphics, recordings, etc. may be made of my dog(s) by Sandy Pawz Dog House and that such may be used for any purpose without compensation, and I release to Sandy Pawz Dog House all rights that I may possess or claim to such image, recording, etc.
- 6. Payment is expected when services are rendered. If Sandy Pawz Dog House pursues collection proceedings, I will pay reasonable attorney's fees and costs of collection.
- 7. Every dog will be examined immediately upon arrival for the presence of fleas. If any fleas and/or flea dirt is found on my dog(s), Sandy Pawz Dog House will proceed with a flea bath for my dog(s) that I assume financial responsibility for.
- 8. I have read and understood all terms of this agreement.

Exit Bath:

Often times when dogs leave boarding, they are less clean than when they arrived, due to interacting with other dogs, etc. It is recommended that an exit bath be purchased along with boarding to ensure that your dog leaves fresh and clean.

Hours of Operation:

Please refer to our brochure or website for store hours. If your dog is not picked up before closing, we will assume that you are boarding and will impose an overnight charge, unless otherwise prearranged.
